OWNER'S AGREEMENT

1. I understand all board and/or training fees must be paid monthly in advance. Failure to comply or removal of horse without payment of any accrued balance shall constitute a breach of contract and an automatic lien on the horse in favor of Arabian Expressions.
2. I agree that before removing horse (s) from Arabian Expressions payment must be made in full by cash, cashier's check or credit card.
3. I understand that if a credit card is used that Arabian Expressions will charge the 2% transaction fee for credit card processing.
4. This horse, to the best of my knowledge, has not been exposed to any contagious or infectious disease for two weeks prior to arrival at Arabian Expressions.
5. I hereby consent to any medical treatment for my horse deemed advisable in any emergency.
6. I consent to any medical treatment for my horse deemed advisable by Arabian Expressions or its veterinarian. I understand I will be responsible for paying these charges.
7. Every precaution is taken to protect the horse from illness, accident, fire, or theft. Arabian Expressions and/or its agents and/or employees shall not be held liable for any loss or injury from illness, accident, fire, or theft, here at the farm, during hauling to or from an event (show exhibition, etc.) or at any event (show, exhibition, etc.).
8. I understand that any lessons, showing, shoeing, veterinary service, shipping and miscellaneous expenses are additional costs and shall be billed accordingly. I agree to pay all additional costs in full upon presentation of billing and prior to the horse's departure.
9. I further agree that in the event that my account with Arabian Expressions becomes delinquent and the farm deems it necessary to turn this matter over to any attorney for collection, I will be responsible for, in addition to the outstanding delinquent balance, all court costs and reasonable attorney's fees incurred in preparation of this matter for litigation.

FLAT RATE:

This is your flat rate fee for each horse that is taken to a horse show with Arabian Expressions. These fees **do not** include the cost of your show entries, prorated grooming stalls, or the cost of transportation to and from the show.*

SURCHARGE A AMOUNT TO BE DETERMINED
Board fees are based on 10lbs supplemental grain and two flakes of hay daily.
There will be a surcharge if horse exceeds this daily ration.

SURCHARGE B.....\$10.00/\$5.00 FARRIER
There will be an additional handling fee of \$10.00 when horse is shod
There will be an additional handling fee of \$5.00 when horse is trimmed

SURCHARGE C.....\$ BLANKET WASHING/DRYING

ADVERTISING

Clients will purchase one page of advertising in a National Trade Journal, for a Top Ten or Better win at the Scottsdale Show, Regional Championship, Canadian or U.S. Nationals Championship Show. This ad must accompany the Arabian Expressions spread.

SELLER'S AGENT FEE

Arabian Expressions receives 20% commission on the sale price of any horse sold by Arabian Expressions, payable at the time of the sale. Arabian Expressions will also receive a 20% commission from any horse sold 90 days after the horse leaves the care of Arabian Expressions if Arabian Expressions institutes the sale, or if the horse was viewed at Arabian Expressions, or in the arena with Arabian Expressions. Arabian Expressions will receive a 10% commission, payable at the time of sale, of any horse in its care, regardless of who is the agent for the sale.

CREDIT CARD AUTHORIZATION

Arabian Expressions requires a credit card to be on file. Client has the option of having Arabian Expressions to charge credit card for monthly charges. If other form of payment is not received in the office by the 10th of each month, Arabian Expressions will charge the credit card on file on the 11th for the balance in full.
